GROUNDS: Held in Bandera at Mansfield Park.

ELIGIBILITY: Open to individual artists and craftsmen presenting their original works. No manufactured, imported or resale items will be allowed in the Arts and Crafts area. We do have an area for commercial goods but the applicant must complete a Commercial Booth form.

REGISTRATION: The registration fee is \$40 per space for the one day show. There will be no price limit on your items sold and no commission will be taken. All registration forms must be accompanied by photographs (returned with S.A.S.E. only), or by photos emailed to the event coordinator. A check or money order payable to *Bandera County Library* must be included.

Deadline for application is March 6th, 2017.

SPACES: Open spaces *only* are provided and will be 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, or umbrella, please specify and give dimensions. There will be a limited number of spaces available. Electricity will be available on a strictly limited basis at an additional charge of \$10 per space. Contact the Event Coordinator for additional information.

SELECTION: To offer the highest sales opportunity to our vendors, this event will be juried for balance of show. Applications will be on a first come basis.

There will be no refunds after March 13, 2017 and no refunds should bad weather occur.
